Tarna introduced Bob Conlin, retiring ETF Secretary.

Mr. Conlin reaffirmed that the WRS is in good hands with the Management Team and the last few years Mr. Villa has developed a succession plan with capable individuals. Mr. Conlin had served as a member of the SWIB Board of Trustees.

Mr. Conlin thanked the WCOA for their support.

He introduced John Voelker who has been Deputy Secretary, for the last 14 years, and will formally be ETF Secretary on April 5, 2021. Mr. Voelker will also replace Mr. Conlin on the SWIB Board of Trustees.

WCOA Chair Bob Schaefer thanked Mr. Conlin for his service and that he is leaving the WRS as the best retirement system in the nation.

With the news this morning, Mr. Voelker has requested to delay his presentation until our March 15, 2021meeting.

#### GUEST: Tarna Hunter, Director of Strategic Engagement and Government Relations, ETF.

ETF has published their 2019 Comprehensive Annual Financial Report (CAFR), online.

The 1099-R form from ETF has an error. Box 12 should be box 14 and box 13 should be 15. The boxes name and content is correct. A letter is being mailed correcting the error.

The legislature has a number of Covid-19 bills for retirees returning to work. There has been some interest shown by retirees, however, legislatively little action.

Tarna and Jay Risch, SWIB, have met with newly elected legislators and began orienting them to the WRS.

The Governor will be releasing his budget tomorrow. The GIB meeting is Wednesday. The Employee Trust Funds Board meets on March 25. Tarna thanked WCOA for the letter to the Governor and Legislative leaders.

Returns for the year were the core fund at 15.2% and variable fund at 17.5%. The annuity adjustment for the core 4.7% to 5.1% and for the variable 10% to 14%. The five and 10 year numbers were also positive.

The January 31, 2001 gross returns are core -.6 and variable also -.6. Those are not net of fees. In the future most returns will be net of fees, following LAB recommendation.

John Voelker, ETF Secretary, has been appointed to the SWIB Board.

The SWIB Incident Command Team is working on a return to office plan with the earliest being July 1. There will be a need for additional office space.

Podcast this month is a review of 2020 and looking forward to 2021.
